Indiana Camp golf cart policy

THE RULES

Violations:

To better your golf cart experience at camp, there are some rules you must comply with. The district camp golf cart policy is in our District manual.

Golf cart renters are required to leave a credit card on file with the camp office as a deposit in case of the following violations:

- A minor under the age of 16 driving the cart without a valid license - \$10.00
- Headlight or tail light damage - \$20.00
- More than the maximum number of people on the cart – (max 4 in carts w/ 2 seats -\$10.00)
- Negligent driving – determined by the security officer on duty - \$10.00
- Not following posted traffic direction signage - \$10.00
- Driving carts on public streets or roads - \$10.00
- Towing carts, bicycles, or any other object - \$10.00
- Driving while holding an infant or child in your lap - \$10.00
- Driving your cart without a muffler or a defective muffler - \$10.00
- Parking in non-designated areas - \$10.00

Damages:

Furthermore, as with any personal property, care must be taken. All golf cart drivers and drivers of all off-road and motorized vehicles bear responsibility for **every/and any** damage to camp-owned carts and any **personal property damaged using camp-owned carts**. The above-listed drivers/owners must leave a Liability and Violation deposit to operate on the campgrounds. Indiana UPC Camp will hold deposits by camp-authorized personnel. **Indiana District UPCI is authorized to make any charge against the liability and violation deposit for damages. In case of loss or theft of district-owned golf carts, the renter is responsible for the total replacement cost.** In case of damage to district-owned carts, the renter will pay for the damages at the prevailing retail price of parts, small materials, and labor at the rate of \$25.00 per hour. In addition, the renter will pay for any lost rentals while the car is lost or damaged.

In addition to the above, district-owned cart renter will be charged as follows in case of loss and/or damage: (List serves as an example of most common damages. Damages are not limited to the following):

- Cart key lost/stolen or damaged - \$20.00
- Security lock lost/stolen or damaged - \$20.00
- Canopy top damaged - \$500.00
- Seat bottom lost/stolen or damaged - \$200.00
- Seat back lost/stolen or damaged - \$50.00 ea.
- Headlight lost/stolen or damaged - \$45.00
- Tail light lost/stolen or damaged - \$65.00
- Altered motor - \$50.00
- Bezel lost/stolen or damaged - \$20.00
- Footrest damaged - \$150.00
- Windshield damage - \$200.00
- Tires/wheel lost/stolen or damaged - \$65.00
- Cart stickers lost/stolen or damaged - \$60.00
